Dear Mr. Widerburg:

Sprint Communications Company L.P. ("Sprint Communications") respectfully requests that the Public Service Commission of Utah ("Commission") cancel Sprint Communications' certificate to provide competitive local exchange and interexchange telecommunications services in Utah.

The Commission authorized Sprint Communications to provide competitive local exchange service and interexchange services in Utah pursuant to a report and order issued by the Commission on January 14, 1997 in Docket No. 96-094-01. Sprint Communications has obtained the required FCC 47 CFR 63.71 approvals to discontinue service and no longer has customers receiving any basic local service or interexchange telecommunications services requiring a certificate. Accordingly, there are no customers in Utah to be notified regarding this request, and cancellation of Sprint Communications' certificate will have no adverse consequences for consumers in Utah.

Sprint Communications also requests to withdraw any tariffs on file with the Commission.
