On September 24, 2021, Sprint Communications Company L.P. ("Sprint") filed a request with the Public Service Commission (PSC) seeking to cancel its certificate of public convenience and necessity to provide local exchange services in Utah ("CPCN") and withdraw its tariffs. The PSC originally issued Sprint a CPCN on January 14, 1997 in Docket No. 96-094-01.

The Division of Public Utilities (DPU) filed comments on October 6, 2021. DPU states that Sprint has no Utah customers and therefore is not required to provide customers notice of cancelation. DPU also states that Sprint has complied with the rules related to canceling a CPCN under Utah Admin. Code R746-350, et seq., and therefore recommends the PSC approve Sprint's request.

Based on the PSC's review of Sprint's request and DPU's recommendation, and since no opposition to the request was filed, the PSC finds cancelation of Sprint's CPCN is in the public interest and approves Sprint's request. Accordingly, Sprint's CPCN, issued on January 14, 1997 in Docket No. 96-094-01, is canceled, effective as of the date of this order.

Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
