ORDER CANCELING CERTIFICATE OF
PUBLIC CONVENIENCE AND NECESSITY

ISSUED: March 1, 2021

On February 5, 2021, Talk America Services, LLC (“Talk America”) filed a request with the Public Service Commission (PSC), seeking cancellation of its Certificate of Public Convenience and Necessity (“CPCN”). On February 22, 2021, the Division of Public Utilities (DPU) submitted a memorandum representing that Talk America has no customers in Utah and has complied with Utah Admin. Code R746-350. DPU recommends the PSC cancel Talk America’s CPCN.

Based on the foregoing and there being no opposition, the PSC finds cancellation of Talk America’s CPCN is in the public interest. Accordingly, Talk America’s CPCN, issued on November 25, 2014 in Docket No. 14-2236-01, is canceled, effective the date of this order.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this written order by filing a request for review or rehearing with the PSC within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the PSC fails to grant a request for review or rehearing within 30 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
