MCImetro Access Transmission Services Corp. d/b/a Verizon Access Transmission Services ("MCImetro Corp.") respectfully notifies the Utah Public Service Commission ("Commission") of its name change to MCImetro Access Transmission Services LLC d/b/a Verizon Access Transmission Services ("MCImetro LLC") as the result of its conversion from a corporation to a limited liability company on July 31, 2021. MCImetro Corp. has registered the new name with the Utah Division of Corporations and Commercial Code and the corresponding registration document(s) are attached. MCImetro Corp. respectfully requests the Commission to issue an updated certificate reflecting the new name (MCImetro Corp. provides competitive local exchange service pursuant to the order issued on January 29, 1997 in Docket No. 96-095-02).
