On May 25, 2021, Emery Telecommunications & Video, Inc. (“Emery”) filed with the Public Service Commission (PSC) a Motion to Withdraw (“Motion”) its Petition for Designation as an Eligible Telecommunications Carrier (ETC) in the State of Utah for the Purpose of Receiving Rural Digital Opportunities Fund (RDOF) and Lifeline Support in this docket.
