Pursuant to the Federal Communications Commission's October 9, 2020 Report and Order in WC Docket No. 18-156, FCC 20-143, ("8YY R&O") and Section 51.911(c) of the Federal Communications Commission's rules, 47 C.F.R. §51.911(c), Granite Telecommunications, LLC ("Granite") submits to the Utah Public Service Commission revised sheets 1 and 67 to its Utah switched exchange access service tariff, Utah Price List No. 2.

With this submission, Granite complies with the 8YY R&O by bifurcating its originating access rates between toll-free (8YY) and non-toll-free rates and benchmarking its toll-free originating rates to the corresponding interstate access rates for Utah as set forth in Granite's interstate F.C.C.
