Re: Docket No. 21-2478-01, *Neutral Tandem-Utah, LLC – Notification Regarding the Proposed Transfer of Indirect Control of Onvoy, LLC, Broadvox-CLEC, LLC, ANPI Business, LLC, and Neutral Tandem-Utah, LLC to Sinch US Holding Inc.*

All:

The Public Service Commission (PSC) has reviewed the joint notification of GTCR Onvoy Holdings LLC, Onvoy, LLC, Broadvox-CLEC, LLC, Neutral Tandem-Utah, LLC, and Sinch US Holding Inc. (collectively the “Applicants”) of the proposed change in indirect control (“Notification”) filed July 9, 2021. The Notification describes the Applicants, explains the transaction/reorganization, provides certain information consistent with Utah Admin. Code R746-349-7, Informal Adjudication of Certain CLEC Merger and Acquisition Transactions, and discusses the public interest consideration. The Notification states that approval of the proposed changes in indirect control is not required.¹

¹ On this point the Notification asserts only notice of the transaction is required, citing: Utah Code Ann. § 54-8b-3.4.

The PSC has also reviewed the Division of Public Utilities' (DPU) comments, filed July 29, 2021, recommending the PSC acknowledge the Notification. DPU states the Applicants have complied with the requirements of Utah Admin. Code R746-349-7.

No party has identified a statutory or other legal requirement for the PSC to approve the noticed change in indirect control, and no party has requested a declaratory ruling on the issue pursuant to Utah Admin. Code R746-101-1, *et seq.* Accordingly, the PSC acknowledges the filing of the Notification and gives notice it will take no further action in this docket unless a party files a request for action and explains the basis on which the PSC may or should act.
