## **BACKGROUND**

On December 6, 2011, in Docket No. 11-2543-01,<sup>1</sup> the Public Service Commission (PSC) granted Spectrotel, Inc. ("Spectrotel") a Certificate of Public Convenience and Necessity ("CPCN"), authorizing it to provide public telecommunication services within the State of Utah.

On January 29, 2021, Spectrotel filed a letter with the PSC indicating the completion of an internal corporate reorganization resulting in the creation of a new affiliate, Spectrotel of the West LLC. Spectrotel indicates its new affiliate will be the new telecommunications service provider for its Utah customers.

On February 12, 2021, the Division of Public Utilities (DPU) submitted a memorandum recommending the PSC approve the notice, the creation of the new affiliate, and the transfer of the CPCN to the new affiliate. DPU expects no opposition to the notice, and recommends the PSC adjudicate the docket informally in accordance with Utah Admin. Code R746-110-1.

#### **ORDER**

There being no opposition, the PSC adjudicates this docket informally, consistent with Utah Code Ann. § 54-8b-3(1)(b). Having reviewed the record, the filing, and DPU's

Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the PSC fails to grant a request for review or rehearing within 30 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
