By this letter, Mobilite Management, LLC (“Mobilite Management”) respectfully requests the Public Service Commission of Utah (“Commission”) to cancel its Certificate of Public Convenience and Necessity (“CPCN”) to provide local exchange telecommunications services in the State of Utah, which was issued on May 27, 2016 in Docket No. 16-2589-01, and to withdraw any tariffs on record, to be effective as soon as the Commission can take appropriate action.
