To the Commission:

As contemplated in Docket 20-2619-01 (the "CPCN Docket") and the Commission's Order granting CPCNs to E Fiber Moab, LLC ("E Fiber Moab") and E Fiber San Juan, LLC ("E Fiber San Juan"), and in accordance with Utah Administrative Rule R746-405 E Fiber Moab and E Fiber San Juan hereby file a combined original new local tariff for the service to be provided in Grand and San Juan Counties. The attached tariff shall be entitled E Fiber San Juan, LLC and E Fiber Moab, LLC PSC Utah No. 1. (the "Tariff"). This Advice Letter will identify key provisions for the new entities.

1. Access Line Service Rates (See Sheet 18)

R1 and B1 Rates set at \$18.00, the affordable base rate as set forth in R748-8-401(c) to include toll free calling between the exchanges in San Juan and Grand County, as communities of interest. No separate extended area service rate element is contemplated because the switching technology between these exchanges does not result in any material incremental costs. The proposed \$18.00 rate is slightly higher than the \$17.50 rates modeled in the E Fiber CPCN Dockets but is consistent with the affordable base rate as set forth in R746-8-401(c) and the CPCN Docket.

2. <u>Custom Calling Features</u> (See Sheets 32-34)

As the Commission is aware, currently customers in Grand and San Juan counties are customers of the Emery Telecommunications & Video, Inc. ("ET&V CLEC"). The current ET&V CLEC basic rate of \$17.50 includes all available call features. As of the effective date of this Tariff, the ET&V CLEC fiber customers will be transitioned to the

E Fiber entities with call features activated. Customers will have the option of discontinuing features. Because of the low incremental cost of providing the features and pressure to compete against feature rich cellular and VoIP base offerings, the accompanying tariff proposes a simple all-inclusive price of \$2.00 per month for any, and all, features with the exception of voice mail which is presented separately in the Tariff for an additional \$1.50. No call feature revenue was modeled in the E Fiber entity CPCN Docket, so this rate will only have a beneficial impact on the projected revenue for the E Fiber entities, and thus the Utah Public Telecommunications Service Support Fund ("UUSF") as applicable.

The Board of Directors of the E Fiber Moab and E Fiber San Juan have approved the Tariff. Current ET&V CLEC fiber customers were notified on December 1, 2021 regarding the transition to the E Fiber entities and the associated pricing changes discussed above. The Tariff sheets as proposed do not constitute a violation of state law or Commission rule.

E Fiber Moab and E Fiber San Juan respectfully request that the Commission accept the Tariff with the proposed effective date of January 1, 2022. While January 1, 2022 is less than thirty (30) days from today's date, as indicated above, the ET&V CLEC fiber customers have received notice of the transition and pricing changes. Consistent with and pursuant to R746-405.E.3, the Commission may, for good cause shown, authorize tariff sheets to become effective before the end of the thirty (30) day period. E Fiber Moab and E Fiber San Juan hereby request approval of the tariff effective January 1, 2022 so that the transition of the assets and billing by the E Fiber entities may commence as of that date. This will simplify accounting procedures and is permitted under the Commission's Administrative Rules.
