On March 31, 2021, the Division of Public Utilities (DPU) filed a Motion to Amend Schedule and Request for Expedited Treatment (“Motion”). DPU states they are seeking additional time to pursue a settlement in this docket. DPU requests the Public Service Commission (PSC) amend its January 20, 2021 Scheduling Order to allow non-applicant parties to file direct testimony by April 5, 2021.

The DPU states it has communicated with the parties to this docket and represents that the Office of Consumer Services, the Utah Rural Telecom Association, and Starlink Services, LLC (collectively, the “Parties”) support the Motion.
