"In the Settlement, the Parties stipulate and agree that: Starlink (1) meets, and will continue to meet, the requirements for Federal ETC designation, (2) will provide Internet speeds *of 1 Gbps with low latency to a minimum of 141 locations* of at least 100 Mbps download and 20 Mbps upload within the RDOF serving area, and (3) will offer an interconnected VoIP service that includes unlimited local and long distance calling within the United States and provides access to emergency services through 911 or E-911." Emphasis added.

It should read,

"In the Settlement, the Parties stipulate and agree that: Starlink (1) meets, and will continue to meet, the requirements for Federal ETC designation, (2) will provide Internet speeds, to approximately 8630 locations as identified in Attachments A & B, of at least 100 Mbps download and 20 Mbps upload within the RDOF serving area, and (3) will offer an interconnected VoIP service that includes unlimited local and long distance calling within the United States and provides access to emergency services through 911 or E-911."
