On August 20, 2021, the Public Service Commission (PSC) issued a Notice of Filing and Comment Period (“Notice”) in this docket, inviting comments by September 17, 2021 and reply comments by October 4, 2021. The Notice also stated, pursuant to Utah Code Ann. § 54-8b-3, “[i]f no comment is filed in opposition to the application, the PSC will adjudicate this docket informally and without hearing.”

On September 10, 2021, the Division of Public Utilities (DPU) filed comments recommending the PSC reject EarthGrid PBC’s application. On September 13, 2021, EarthGrid PBC filed responsive comments. Nothing has been filed in the docket since September 13, 2021.
