To the Commission:

In accordance with R746-340-1 and R746-405 of the Public Service Commission's Rules, the above referenced companies (the "Companies") hereby electronically files the following Intrastate Access Tariff, PSC Utah No. 3. This Intrastate Tariff represents a restated and revised Intrastate Access Tariff for Emery Telephone, Carbon/Emery Telcom, Inc. and Hanksville and the initial Intrastate Access Tariff for E Fiber Moab, LLC and E Fiber San Juan, LLC. As this is a new tariff filing, all sheets are identified as "Original." Given a change in formatting between the PSC Utah No 2 Tariff and this PSC Utah No 3 Tariff, a mark-up was not possible, however, we have summarized the material changes below:

- 1. E Fiber Moab, LLC and E Fiber San Juan, LLC were added to the header of each page, and the title page 1 and the Tariff is named PSC Utah No 3.
- 2. The Explanation of Symbols was removed from page 1.
- 3. Beginning on Page 35, some the Rates were modified and additional rate points were added:

a. Page 35: 17.3.2 (F) the originating rate for Hanksville was revised from \$0.002650 to \$0.0002650. This was a previous misprint in the Tariff. Hanksville has been charging customers the correct rate of \$0.0002650;

- b. Page 35: 17.3.2(G) Joint Tandem Switched Transport Rate element was added at \$0.001 per minute;
- c. Page 36: 17.3.2 (I) 800 Series Data Base Access Service Queries per query rates were lowered:

i. Basic from \$0.0053 to \$0.004248 ii. Vertical Features from \$0.0059 to \$0.004248

- d. Page 37: The rate for Local Switching Originating Access Minute was broken into two categories: "Originating Per Access Minute (Non-Toll Free)" and "Originating Per Minute Access Minute (Toll-Free)"
- e. Page 39: The Additional Engineering Rates were increased to reflect increased labor costs:
 - i. Basic was increased from \$32.50 to \$37.50
 - ii. Overtime was increased from \$48.75 to \$56.25
 - iii. Premium time was increased from \$65 to \$75
- f. Page 40: The Additional Labor Rates were increased to reflect increased labor costs:
 - i. Basic was increased from \$32.50 to \$37.50
 - ii. Overtime was increased from \$48.75 to \$56.25
 - iii. Premium time was increased from \$65 to \$75
- g. Page 41: Section 17.4.3 Labor Rates were increased to reflect increase labor costs:
 - i. Basic was increased from \$32.50 to \$37.50
 - ii. Overtime was increased from \$48.75 to \$56.25
 - iii. Premium time was increased from \$65 to \$75
- h. Pages 45 and 46: Section 17.5 describing the transition from Non-LTR Rate Design to LTR Rate Design was removed because the transition is completed. Section 17.5 and Page 46 are RESERVED FOR FUTURE USE.
- i. Page 47: Section 17.6 was revised to reflect the Rate Schedule for Transition per FCC 8YY Order Dated October 7, 2020.

j. Pages 48, 49, and 50: Section 17.8.1 Public Packet Switching Rates were revised to show additional incremental speeds and rates.

The Board of Directors of the Companies have approved the Tariff. The Intrastate Access Tariff PSC Utah No 3 as proposed does not constitute a violation of state law or Commission rule. Pursuant to R746-405-2.E(3) the Companies requests an effective date for this filing of February 28, 2022, which is earlier than the thirty day notice period to more quickly effectuate the new tariff for the E Fiber entities.
