To the Commission:

In accordance with R746-340-1 and R746-405 of the Public Service Commission's Rules, the above referenced companies (the "Companies") hereby electronically files modified Intrastate Access Tariff, PSC Utah No. 2. This Intrastate Tariff adds E Fiber Moab, LLC and E Fiber San Juan, LLC. A PDF file entitled Compare Report – Redline Existing Filed Tariff with Revised Emery Intrastate Tariff June 1-2022 is also attached which shows the changes which are also summarized below:

1. E Fiber Moab, LLC and E Fiber San Juan, LLC were added to the header of each page, and to the title page 1.
2. The footer of each page was modified to show the Issue Date, Effective Date, and Advice/Dkt numbers.
3. Page 2 which contains the Check Sheet was modified to reflect the correct sheet numbers and revision effective dates.
4. Page 3 which contains the Table of Contents was revised to remove the "Explanation of Symbols."

5. Page 4 which is the second page of the Table of Contents was revised to identify the Rate Schedule for Transition per FCC 8YY Order Dated October 7, 2020.
6. Page 5 was revised to remove the Explanation of Symbols and throughout the Tariff, the column on the right side of each sheet containing symbols was removed; additionally “as defined herein” was added to the last paragraph on page 5.
7. Quotation marks were added to “Telephone Company” on page 6.
8. On page 15, the last sentence of Section (B) and on page 16, the last sentence of Section (C) which read “For companies that have a transitional rate this rate will be in effect from July 1, 2012 through June 30, 2013” was deleted as obsolete.
9. On page 33, E Fiber San Juan, LLC and E Fiber Moab, LLC were added to Section 17.
10. On page 35, E Fiber San Juan and E Fiber Moab were added to Section (E) “Originating” and Section (F) “Originating”; also the rate element for Hanksville Originating Tandem Switched Termination was revised to \$0.0002650. It has previously been noted as \$0.002650, but that was a typographical error/misprint in the previous tariff. The rate has been \$0.0002650 and no customers were charged the higher rate despite the misprint.
11. On page 36, the section on 800 Series Data Base Access Service Queries was corrected to be identified as Section (I) (rather than a second (H) as in the previous tariff.
12. On page 37, E Fiber San Juan and E Fiber Moab were added to Section 17.3.4 End Office – LTR IntraState (A) Local Switching and Section 17.3.5 End Office – Non LTR IntraState (A) Local Switching.
13. On page 41, the Central Office Maintenance Technician Rate was increased from \$32.50 to \$37.50; the overtime per technician rate was increased from \$48.75 to \$56.25; and the premium time per technician rate was increased from \$65 to \$75. This change in rate was inadvertently not included in the 2018 tariff change. Note how the rate is now consistent with the previous pages.
14. On pages 45 and 46, Section 17.5, the Rate Schedule Transition from Non-LTR Rate Design to LTR Rate Design language was deleted as obsolete because the transition is completed. Section 17.5 is “Reserved for Future Use” as is page 46.
15. Page 47 in the Rate Element Table, E Fiber San Juan and E Fiber Moab were added and the LS Rate for Hanksville Originating (Toll Free Only) traffic was changed from

\$0.030075 to \$0.018456 in 2021 and from \$0.015037 to \$0.009228 in 2022. The Hanksville Originating (Toll Free Only) rates, post FCC Order issued October 7, 2020, should have been limited to the Hanksville originating rate prior to the order, then reduced to zero over time. The previous tariff incorrectly used the pre-order Carbon originating rate rather than the pre-order Hanksville originating rate as a starting point for the 8YY originating price. This tariff change properly states the FCC allowed maximum Hanksville originating 8YY rate for 2021, reduces it by half in 2022, and shows it going away in 2023 in accordance with the Order.

16. On page 49, the Table (C)(2) was moved to page 50 in the revised tariff. No changes to the rates were involved.

The Board of Directors of the Companies have approved the revision to the Tariff. The Intrastate Access Tariff PSC Utah No. 2 as proposed does not constitute a violation of state law or Commission rule. Pursuant to R746-405-2.E(2) the Companies requests an effective date for this filing of July 1, 2022 which is 30 days after filing.
