ISSUED: March 31, 2023

Consistent with discussion among the participants of the March 22, 2023 scheduling conference, on March 30, 2023, the Office of Consumer Services (OCS) filed with the Public Service Commission a Stipulated Motion Regarding Notice of Withdrawal of Petition for Statewide Exemption from the Carrier of Last Resort Obligation and Request for Expedited Treatment ("Motion"). The parties to the Motion are OCS, CenturyLink, and the Division of Public Utilities ("Parties").¹

OCS states the purpose of the Motion is to: (1) convert CenturyLink's March 22, 2023 "Notice of Withdrawal of Petition" to a "Motion to Withdraw its Petition"; (2) stipulate that there is no opposition to the conversion of the Notice to a Motion; (3) clarify the language in CenturyLink's Notice of Withdrawal of Petition to better reflect the Parties' agreement; and (4) demonstrate there is no opposition to the Motion. The Parties seek expedited treatment of the Motion while also allowing time for public comments on the Motion.

¹ The Utah Rural Telecom Association has engaged in discussions with the Parties throughout the course of this docket, but has not formally intervened.
