dishNET Wireline L.L.C. (“dishNET”) submits to the Utah Public Service Commission revised amended Sheet Nos. 2 and 58 and amended Sheet No. 44 to dishNET’s retail local exchange price list, Utah Price List No. 4, for incorporation into the Company’s Price List.

With this submission, dishNET removes a no longer applicable reference to waiving a Residential Package F line charge, that had been inadvertently retained in dishNET’s September 16 submission under Advice Letter No. 20 on Sheet No. 58. The reference also appeared on Sheet No. 44, which is now included in this submission along with an amended Check Sheet reflecting inclusion of Sheet No. 44. As this amendment is purely ministerial and impacts no subscribers, the issue and proposed effective dates remain unchanged.
