On April 7, 2022, the Public Service Commission (PSC) issued a Scheduling Order and Notice of Hearing ("Scheduling Order") in this docket establishing filing deadlines and an inperson hearing for September 14, 2022. On July 11, 2022, AirVoice Wireless, LLC ("AirVoice") filed a Motion to Participate Telephonically in Hearing ("AirVoice's Motion"). AirVoice requests its counsel and witness be allowed to participate in the hearing telephonically. AirVoice states the Office of Consumer Services (OCS) and the Division of Public Utilities (DPU) do not object to AirVoice's Motion.
