Dear Ms. Wagner,

Between November 17, 2023 and December 22, 2023, Qwest Corporation dba CenturyLink QC ("CenturyLink") filed with the Public Service Commission (PSC) interconnection agreements (collectively, the "Agreements"), and amendments to interconnection agreements (the "Amendments") between CenturyLink and the carriers referenced above ("Identified Carrier"). The proposed Agreements define the terms and conditions under which CenturyLink will provide service to the Identified Carrier and the Amendments add terms and conditions to existing Interconnection Agreements between the Identified Carrier and CenturyLink.

Between November 22, 2023 and January 10, 2024, the Division of Public Utilities (DPU) filed comments recommending the PSC acknowledge receipt of the Agreements. DPU states that the Agreements and Amendments were voluntarily negotiated in good faith and without unfair discrimination, and it sees no reason to reject them.
