Re: **Docket No. 23-049-05**, Agreement filing in the Matter of the Amended Interconnection Agreement between Qwest Corporation d/b/a CenturyLink QC and Granite Telecommunications, LLC.

Recommendation (Acknowledge)

The Division of Public Utilities (“Division”) recommends that the Public Service Commission (“Commission”) acknowledge the receipt of this Amended Interconnection Agreement.

Discussion

On or about November 17, 2023, Qwest Corporation d/b/a CenturyLink QC (“CenturyLink”) filed the Amended Interconnection Agreement per the above-referenced docket in accordance with § 54-8b-2.2(1) (d) of the *Utah Code*. This Agreement had been fully executed through voluntary negotiations on September 16, 2022, and amended November 17, 2023, with Granite Telecommunications, LLC (“Granite”).

The Division has reviewed the above-mentioned Agreement between CenturyLink and Granite and sees no reason to reject it. Specifically, the Division believes that the Agreement was negotiated in good faith and without unfair discrimination. Both parties also recognize that, to the extent that the existing rules are changed, vacated, dismissed,
