**4.7.1 DO-IT-YOURSELF OPTION**

A. Terms and Conditions

1. If the customer elects to provide the labor to place cable, the Company will provide the materials, supervision, engineering and testing as required. This service will be provided to the customer for a charge equal to the costs associated with providing the materials and support services.
2. The Company and the customer will enter into a written agreement for provision of the requested facilities. The agreement will delineate the Company's responsibilities, the customer's responsibilities and the associated construction or facility charge.
3. The ownership of any pole line, circuit, or other facilities provided wholly or in part at the expense of a customer under this Price List shall at all times be vested exclusively in the Company or another company with which the Company has a joint agreement.

**4.7.2 SERVICE STATION LINES**

A. Terms and Conditions

1. Service station customers who request local exchange service will be classified as new applicants for the application of construction charges. New service station customer will be assessed the appropriate construction charges applicable at the point of connection.
2. The customer will be responsible for providing engineering, right-of-way procurement and all needed material for construction of the facility on their side of the interface point.
3. The customer assumes all responsibility for construction and all ongoing maintenance of their line. The Company will only provide maintenance up to the Network Interface.
