ORDER CANCELING CERTIFICATE OF  
PUBLIC CONVENIENCE AND NECESSITY

---

ISSUED: October 31, 2023

On September 5, 2023, BullsEye Telecom, Inc. (“BullsEye”) notified the Public Service Commission (PSC) that its internal reorganization and transfer of customers to Lingo Telecom, LLC (“Lingo”) is complete<sup>1</sup> and seeks to cancel BullsEye’s certificate of public convenience and necessity (“CPCN”) to provide local exchange services in Utah<sup>2</sup> and its tariffs (the “Request”). On that same date, the PSC requested the Division of Public Utilities (DPU) to review the Request and provide recommendations regarding the same. DPU filed its comments on October 17, 2023.

DPU states that the Request is the result of the transfer of BullsEye customers to Lingo which occurred after the above-referenced reorganization. DPU also states that BullsEye has no customers in the State of Utah. DPU indicates that BullsEye has complied with the rules related to cancelling a CPCN under Utah Admin. Code R746-350 and therefore recommends the PSC approve BullsEye’s Request.

Based on the PSC’s review of BullsEye’s Request and DPU’s recommendation, and since no opposition was filed, the PSC finds cancellation of BullsEye’s CPCN and

tariffs is in the public interest and approves BullsEye's Request. Accordingly, BullsEye's CPCN, issued on November 19, 2003, in Docket No. 03-2413-01, and associated tariffs, are canceled, effective on the date of this order.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this written order by filing a request for review or rehearing with the PSC within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the PSC fails to grant a request for review or rehearing within 30 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
