ORDER AMENDING CERTIFICATE OF
PUBLIC CONVENIENCE AND NECESSITY

ISSUED: October 26, 2023

On or about October 6, 2010, in Docket No. 10-2530-01, the Public Service Commission (PSC) granted Mobilitie, LLC a certificate of public convenience and necessity ("CPCN"), authorizing the company to provide public telecommunications services within the state of Utah. Mobilitie, LLC recently changed its name to Boldyn Networks US LLC ("Boldyn") as part of a rebranding and marketing campaign by its ultimate parent company, BAI Communications Group.

On September 25, 2023, Boldyn notified the PSC of its name change (the "Notice") representing that "the Company's name change does not entail any restructuring, merger or other transaction impacting the corporate existence or management of the Company and ... will not affect the services or rates provided to customers[.]"¹

On October 6, 2023, the Division of Public Utilities (DPU) filed a memorandum ("Comments") recommending the PSC acknowledge the requested name change, make necessary changes and amendments to all required documents, and adjudicate the docket informally in accordance with Utah Admin. Code R746-110-1.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this written order by filing a request for review or rehearing with the PSC within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the PSC fails to grant a request for review or rehearing within 30 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
