ISSUED: September 15, 2023

On August 9, 2023, the Public Service Commission (PSC) issued the Scheduling Order and Notice of Virtual Hearing in this docket ("Scheduling Order"). That order provided applicant TerraCom, Inc. d/b/a Maxsip Tel, LLC ("Applicant") until August 17, 2023, to file its written direct testimony ("Applicant's Direct Testimony"). On August 29, 2023, Applicant's Direct Testimony was filed, along with a Motion to Late File Pre-Filed Direct Testimony of David Tatum ("Motion").

The Motion seeks to submit Applicant's Direct Testimony beyond the deadline in the Scheduling Order.
