Petition of TerraCom, Inc. d/b/a Maxsip Tel for Designation as an Eligible Telecommunications Carrier in the State of Utah and to Participate in the Utah Universal Service Fund	Docket No. 23-2642-01 SETTLEMENT STIPULATION AND JOINT MOTION FOR A VIRTUAL HEARING DATE AND FOR EXPEDITED TREATMENT

Pursuant to Utah Code section 54-7-1 and Utah Administrative Code R746-1, the Division of Public Utilities (“Division”), the Office of Consumer Services (“OCS”), and TerraCom, Inc. d/b/a Maxsip Tel (“TerraCom”) (collectively the “Parties”) file this Settlement Stipulation and Joint Motion for a Virtual Hearing Date and for Expedited Treatment (“Motion”). The Parties have entered into a Settlement Stipulation and, pursuant to Utah Code section 54-7-1, seek Public Service Commission of Utah (“Commission”) approval of the Settlement Stipulation filed concurrently with this Motion as Exhibit 1. The Parties request the Commission schedule a virtual hearing on November 7, 2023, at 1:00 pm, to consider approval of the Settlement Stipulation. There are no intervenors in this docket.

On July 27, 2023, TerraCom filed its Petition for Designation as an Eligible Telecommunications Carrier in the State of Utah and to Participate in the Utah Universal Service

Fund (“Petition”). On August 9, 2023, the Commission issued a Scheduling Order and Notice of Virtual Hearing. On August 29, 2023, TerraCom filed the Pre-Filed Direct Testimony of David Tatum in support of its Petition. Because of ongoing settlement discussions, on October 16, 2023, the Parties filed a Joint Motion to Vacate the Scheduling Order and for Expedited Treatment. On October 18, 2023, the Commission issued an order granting the motion.

The Parties have now reached a final settlement, as delineated in the attached Settlement Stipulation, and request the Commission schedule a virtual hearing on November 7, 2023, at 1:00 pm, for Commission approval of the Settlement Stipulation. Finally, because this is a joint motion of all parties and the time for briefing the Motion will not expire before the requested hearing date, the Parties request expedited treatment of this Motion.
