The Public Service Commission of Utah (the “Commission”) entered a Scheduling Order in this docket on September 16, 2024 (the “Scheduling Order”) which set the deadlines for filing testimony, intervention, rebuttal testimony, and surrebuttal testimony, and which set the hearing in the matter for December 4, 2024 at 9:00 a.m. Pursuant to Utah Code §54-7-1 and the Rules of the Commission, The Manti Telephone Company (“Manti”) and Lynch Telephone Corporation X (“Lynch”) (Manti and Lynch collectively, the “Applicants”), together with the Division of Public Utilities (the “Division”) (collectively the “Parties” or singly “Party”) submitted a

Settlement Stipulation (“Stipulation”) for Commission consideration on October 29, 2024. The Settlement Stipulation resolves all contested issues in this docket. Therefore, the Parties now jointly move for an order vacating all dates in the Scheduling Order, except for the Hearing Date currently set for December 4, 2024, at 9:00 a.m. (the “Hearing”). The Parties anticipate calling witnesses to support the Settlement Stipulation at the Hearing on December 4, 2024 at 9:00 a.m.

Finally, because this is a Joint Motion of all parties and the time for briefing this Motion will not expire before the deadlines for filing testimony (non-party direct and rebuttal) and intervention, the Parties request expedited treatment of this Motion.
