## Recommendation (Acknowledge)

The Division of Public Utilities (“Division”) recommends that the Public Service Commission (“Commission”) acknowledge the receipt of this Amended Interconnection Agreement.

## Discussion

On or about February 02, 2024, Qwest Corporation d/b/a CenturyLink QC (“CenturyLink”) filed the Amended Interconnection Agreement per the above-referenced docket in accordance with § 54-8b-2.2(1) (d) of the *Utah Code*. This Agreement had been fully executed through voluntary negotiations on January 24, 2024, with MCImetro Access Transmission Services, LLC (“MCImetro”).

The Division has reviewed the above-mentioned Agreement between CenturyLink and MCImetro and sees no reason to reject it. Specifically, the Division believes that the Agreement was negotiated in good faith and without unfair discrimination. Both parties also recognize that, to the extent that the existing rules are changed, vacated, dismissed,
