On May 1, 2024, the Public Service Commission (PSC) held a scheduling conference in this docket, with representatives from New Cingular Wireless PCS, LLC, the Division of Public Utilities, and the Utah Rural Telecom Association in attendance. During the scheduling conference, the presiding officer requested the participants to provide legal briefing on two specific topics relating to the April 10, 2024 Verified Request for Recovery of Overpayment to UUSF ("Request"). The requested briefs shall contain a maximum of ten pages regarding each topic and are to be filed with the PSC on or before **Thursday, May 30, 2024**.

At the conclusion of the scheduling conference, it was determined that further discussions among the participants were necessary to arrive at a more robust schedule for adjudicating the Request.
