Overpayment of New Cingular Wireless PCS, LLC, an AT&T Company, into the Utah Universal Service Support Fund

ORDER GRANTING STIPULATED MOTION
TO SUSPEND DEADLINES IN
SCHEDULING ORDER EXCEPT FOR THE
HEARING DATE AND FOR EXPEDITED
TREATMENT

ISSUED: July 10, 2024

On April 10, 2024, New Cingular Wireless PCS, LLC (“Cingular”) filed with the Public Service Commission of Utah (PSC) a Verified Request for Recovery of Overpayment to UUSF. On May 14, 2024, the PSC issued a Scheduling Order that included, among other things, a date and time for the submission of written testimony and the hearing in this docket. On July 10, 2024, Cingular filed a Stipulated Motion to Suspend Deadlines in Scheduling Order and requested expedited treatment (“Motion”). The Motion seeks to retain the hearing date of August 13, 2024, but to suspend all remaining deadlines in the Scheduling Order.

Cingular states it is authorized to represent that the Division of Public Utilities (DPU) and the Utah Rural Telecom Association (URTA)¹ support the Motion. Cingular further states it filed the “Motion because it, the Division and URTA have engaged in settlement negotiations and hope to resolve disputes in this docket through further negotiations and present a settlement stipulation to the Commission.”² Finally, the Motion represents that if a settlement “is not reached, the parties anticipate that they

would file a request for a scheduling conference to reset testimony deadlines and a hearing date to allow disputed issues to be addressed.”³

Based on the representations in the Motion and good cause appearing, the Motion is granted. The remaining deadlines of the Scheduling Order are suspended except that the originally scheduled date and time for the hearing will remain as August 13, 2024, at 9:00 a.m.
