Overpayment of New Cingular Wireless PCS, LLC, an AT&T Company, into the Utah Universal Service Support Fund

ORDER GRANTING MOTION FOR  
CONTINUANCE AND MODIFYING  
SCHEDULING ORDER

ISSUED: August 9, 2024

On May 14, 2024, the Public Service Commission (PSC) issued a Scheduling Order and Notice of Hearing in this docket (“Scheduling Order”). The Scheduling Order set various filing deadlines, along with a hearing in this docket for August 13, 2024, at 9:00 a.m. (the “August 13 Hearing”). The Scheduling Order was later suspended except for the August 13 Hearing.

On August 8, 2024, the Division of Public Utilities (DPU) filed a Stipulated Motion to Continue Hearing and Request for Expedited Treatment (“Motion”). The DPU requests the PSC continue the August 13 Hearing to September 19, 2024, beginning at 9:00 a.m. The Motion represents that the parties in this docket – DPU, New Cingular Wireless PCS, LLC (“New Cingular”), and the Utah Rural Telecom Association (URTA) – “have been involved in ongoing settlement discussions and hope to file a settlement stipulation with the [PSC] that resolves the issues in this docket.” The Motion further states that DPU’s counsel “is authorized to represent that [New Cingular and URTA] support and stipulate to [the] Motion.”

Good cause appearing, and based on DPU's representations that the parties support the Motion, the Motion is granted. The Scheduling Order in this docket is modified as follows:
