ORDER GRANTING REQUEST TO RELINQUISH ELIGIBLE TELECOMMUNICATIONS CARRIER AUTHORIZATION

### ISSUED: April 2, 2024

On February 23, 2024, Starlink Services, LLC ("Starlink") filed a request with the Public Service Commission (PSC) seeking to relinquish its designation as an Eligible Telecommunications Carrier (the "Request"). That designation was previously authorized by Order Approving Stipulation and Settlement Agreement dated May 11, 2021, as modified by Erratum Order Approving Stipulation and Settlement Agreement Agreement dated May 27, 2021, in Docket No. 21-2624-01 ("Starlink's ETC Designation").

On February 26, 2024, the PSC issued a Notice of Filing and Comment Period, providing any interested person the opportunity to file comments on the Request by March 27, 2024. On March 15, 2024, the Division of Public Utilities (DPU) filed comments and recommended the PSC approve the Request based on, among other things, that "Starlink has not received universal services support [funds], nor does it have customers in" Utah.

No other person filed comments and the Request is not opposed.

Based on the PSC's review of the Request, DPU's comments, and that no person has opposed the Request or responded to the DPU's recommendation, we find granting the Request is in the public interest.

Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
