ISSUED: April 22, 2024

On April 18, 2024, the Division of Public Utilities (DPU) and the Office of Consumer Services (OCS) filed with the Public Service Commission an Unopposed Joint Motion for Extension of Time to File Non-Applicant Direct Testimony and for Expedited Treatment (“Motion”). The Motion seeks an extension of time within which DPU and OCS shall file their written direct testimony. Under the current scheduling order issued March 11, 2024 (“Scheduling Order”), the direct testimony of the DPU and OCS is due April 24, 2024, and the Motion seeks an extension until May 7, 2024. DPU and OCS represent that petitioner TruConnect Communications, Inc. does not oppose the Motion and that there are no intervenors in this docket.

The Motion represents that the parties are engaged “in good faith settlement negotiations and anticipate reaching a settlement and filing an executed settlement stipulation soon.” The Motion notes that no other Scheduling Order deadlines are impacted by this request.

Good cause appearing and because no party objects, the Motion is granted. The DPU and OCS shall have until **Tuesday, May 7, 2024**, to file their respective written direct testimony. All other dates in the Scheduling Order, including the hearing date, remain the same.
