Pursuant to Utah Code section 54-4a-1 and Utah Administrative Code R746-1, the Division of Public Utilities (“Division”), Office of Consumer Services (“Office”), and TruConnect Communications, Inc. (“TruConnect”) (or collectively “the Parties”) submit this Joint Motion to Vacate the Scheduling Order Except for the Hearing Date and for Expedited Treatment (“Motion”). The Parties have reached a settlement of the issues presented in this docket and have concurrently filed with this Motion the executed settlement stipulation as Attachment 1. There are no intervenors in this docket.

On February 29, 2024, TruConnect filed with the Public Service Commission of Utah (“Commission”) its Petition for Designation as an Eligible Telecommunications Carrier in the State of Utah (“Petition”). On March 11, 2024, the Commission issued a Scheduling Order and Notice of Virtual Hearing. On March 20, 2024, TruConnect filed the Direct Testimony of Danielle Perry in support of its Petition. To allow additional time to finalize a settlement in this

docket, on April 18, 2024, the Division and Office filed an Unopposed Joint Motion for Extension of Time to File Non-Applicant Direct Testimony and for Expedited Treatment. On April 28, 2024, the Commission granted that motion.

The Parties have since reached a settlement resolving the issues in this docket and executed the settlement stipulation attached herein. Accordingly, the Parties request to vacate the Scheduling Order while retaining the virtual hearing date of June 12, 2024, to consider the settlement stipulation and because the deadline for non-applicant testimony is May 7, 2024, also request expedited treatment of this Motion.
