ORDER GRANTING JOINT MOTION TO VACATE SCHEDULING ORDER EXCEPT FOR THE HEARING DATE AND RESTATEMENT OF NOTICE OF VIRTUAL HEARING

ISSUED: May 7, 2024

On February 29, 2024, TruConnect Communications, Inc. filed with the Public Service Commission of Utah (PSC) its Petition for Designation as an Eligible Telecommunications Carrier in the State of Utah ("Petition"). On March 11, 2024, the PSC issued a Scheduling Order that included, among other things, a date and time for the virtual hearing in this docket ("Scheduling Order"). On April 18, 2024, the Division of Public Utilities and the Office of Consumer Services filed a Joint Motion for Extension of Time to File Non-Applicant Direct Testimony. That motion was subsequently granted.

On May 6, 2024, the parties filed a Joint Motion to Vacate the Scheduling Order Except for the Hearing Date ("Motion to Vacate"), representing that settlement has been reached in this docket and included as Attachment 1 the executed Stipulation and Settlement Agreement. The Motion to Vacate requests the PSC to vacate the Scheduling Order as to all dates except the originally scheduled date and time for the virtual hearing.

Good cause appearing, the Motion to Vacate is granted. The Scheduling Order is vacated along with all deadlines and proceedings established therein except that the originally scheduled date and time for the virtual hearing will remain as June 12, 2024, at 9:00 a.m.

RESTATEMENT OF NOTICE OF VIRTUAL HEARING

The PSC gives notice that the virtual hearing to consider the Stipulation and Settlement Agreement submitted on May 6, 2024, in this docket will be held on **Wednesday, June 12, 2024, beginning at 9:00 a.m.** This conference will be conducted via Webex at the following link: <https://utah-psc.webex.com/utah-psc/j.php?MTID=m9b761ad41d734422f66709116cfc8df3>

All parties must have their witnesses in attendance and prepared to testify. The PSC requests that attorneys and witnesses make themselves available by both video and audio during the portions of the hearing in which they will be actively participating. Participants are free to deactivate video, and should always mute audio, when not actively participating.
