On April 3, 2025, the Public Service Commission (PSC) received a letter from RLI Insurance Company ("Letter") representing it canceled bond # CMS0270733 in the amount of \$100,000 issued to Level 3 Communications, LLC ("Level 3"). The PSC gives notice it has opened this docket to inquire about the ramifications, if any, of the bond cancellation on Level 3's compliance with applicable statutes, rules, and PSC orders. A copy of the Letter is attached to this Notice.

The PSC requests the Division of Public Utilities investigate whether the bond's cancellation affects Level 3's compliance with applicable statute, rule, or PSC order. The PSC asks the DPU to file a response to this Action Request on or before **Tuesday, April 22, 2025**.
