### **Re: Advice Letter No. 25-05; Revisions to Price List No. 2**

Dear Commissioners:

Enclosed for filing with the Commission is an electronic copy of this Advice Letter No.25-05 and revised price list sheets for the Utah Price List No. 2 of Zayo Group, LLC.

The following list of revised tariff sheets includes a description of the proposed changes:

- 6<sup>th</sup> Revised Sheet No. 2 and 3<sup>rd</sup> Revised Sheet 3 - Revised Check Sheet
- 2<sup>nd</sup> Revised Sheet No. 75 – Increases ISDN PRI and Digital Voice T1 monthly recurring charges
- 2<sup>nd</sup> Revised Sheet No. 76 – Increases Novus monthly recurring charges
- 2<sup>nd</sup> Revised Sheet No. 77– Increases Integrated T1 monthly recurring charges
- 2<sup>nd</sup> Revised Sheet No. 78 – Increases Integrated PRI monthly recurring charges
- 1<sup>st</sup> Revised Sheet No. 104 – Increases Network Access Assessment percentage

Zayo respectfully requests an effective date of November 1, 2025, for the ISDN PRI, Digital Voice T1, Novus, Integrated T1 and Integrated PRI increases and has given the following notice of rate increase in the October billing cycle:

### **NOTICE OF PRICE INCREASE**

Effective on your November 2025 invoice, for customers out of their initial contract term, monthly rates for Access Bandwidth, DSL, Basic Business Lines over DSL, Broadband, T1/TDM based services, Internet Access, Legacy Internet Services, Integrated Access and Bandwidth, Voice Services, ISP Services, WAN, Cloud Services, Security Solutions, Email & Microsoft services, Web & Video Conferencing, Point to Point Services, Dial-up Internet Access and Conference Now Services will increase by up to 75%.

Effective on your November 2025 invoice, customers whose initial contract term has expired will see a monthly rate increase on ISDN/PRI and DS1 Access (up to \$1750 per ISDN/PRI or DS1 Access), ISDN/PRI Channel Services (up to \$100 per Channel), Analog, Voice, and ISDN/PRI Trunks and ISDN/PRI and T1 Business Lines (up to \$100 per Trunk or Line), Digital Local Loop (up to \$350 per Loop) and T1 Dedicated Internet (up to \$750).

Zayo respectfully requests an effective date of December 1, 2025, for the Network Access Assessment percentage increase and will be providing the following notice of rate increase in the November billing cycle:

### **NOTICE OF PRICE INCREASE**
