Petition of RCLEC, Inc. to Surrender its Certificate of Public Convenience and Necessity DOCKET NO. 25-2583-01

ORDER CANCELING CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

ISSUED: May 13, 2025

On April 3, 2025, RCLEC, Inc. ("RCLEC") filed a verified petition with the Public Service Commission (PSC) requesting the cancellation of RCLEC's certificate of public convenience and necessity ("CPCN") to provide resold and facilities-based local exchange and interexchange services in Utah (the "Petition"). RCLEC asserts it does not offer or provide any service pursuant to the CPCN in Utah. On that same date, the PSC requested the Division of Public Utilities (DPU) review the Petition and provide recommendations regarding the same. DPU filed its comments on May 1, 2025.

DPU's comments represent that it reviewed RCLEC's past annual reports filed in Utah and found that RCLEC has not reported any customers or revenue for some time. DPU also states that RCLEC will continue to provide VoIP services to any existing customers but does not plan to offer any other services in the future. DPU concludes that RCLEC has complied with the PSC rules relating to canceling a CPCN under Utah Admin. Code R746-350 and recommends the PSC approve the Petition.

Based on the PSC's review of the Petition and DPU's recommendation, and since no opposition was filed, the PSC finds cancellation of RCLEC's CPCN is in the public interest and approves the Petition. Accordingly, RCLEC's CPCN, issued on

Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the PSC fails to grant a request for review or rehearing within 30 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
