APPLICATION FOR DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER

LTE Wireless INC ("LTE" or "Applicant"), pursuant to Section 214(e)(2) of the Communications Act of 1934, as amended (the "Act"), Sections 54.101 of the Rules of the Federal Communications Commission ("FCC") and section R746-360-1 of the Utah admin code hereby applies to the Utah Utilities and Transportation Commission ("Commission") for Designation as Eligible Telecommunications Carrier ("ETC") throughout the non-rural areas of Utah for wireless services including tribal areas of the state for the purpose of receiving federal universal service support. As demonstrated below, LTE satisfies all the statutory and regulatory requirements for designation as an ETC in the Designated Service Area. Furthermore, the designation of LTE in the Designated Service Area will serve the public interest. Accordingly, LTE respectfully requests that the Commission grant this application.

I. Introduction

LTE is a South Dakota Corporation and is authorized to conduct business as a foreign corporation in the State of Utah. A copy of the authorization to conduct business in Utah is attached as Exhibit A. The Company will provide wireless services in the Designated Service Areas using a combination of its own facilities and those of its

underlying carriers T Mobile through a wholesale agreement with PrePaid Wireless Group ("PWG"), a T Mobile Virtual Network Operator.

II. LTE MEETS THE STATUTORY AND REGULATORY REQUIREMENTS FOR ETC DESIGNATION

As set forth in Section 214(e)(2) of the Act, the Commission "shall upon its own motion or upon request designate a common carrier that meets the requirements of [Section 214(e)(1)] as an eligible telecommunications carrier for a service area designated by the State Commission." Upon designation as an ETC, the carrier shall be eligible to receive support in accordance with Section 254 of the Act. The requirements for designation as an ETC set forth in Section 214(e)(1) are that the carrier must:

- A. Offer the service that are supported by Federal Universal support mechanisms under section 254(c), either using its own facilities or a combination of its own facilities and the resale of another carrier's services (including the services offered by another eligible telecommunications provider); and
- B. Advertise the availability of such services and the charges therefore using the media of general distribution.

III. LTE SATISFIES THE REQUIREMENTS FOR DESIGNATION AS AN ETC TO SERVE THE DESIGNATED SERVICE AREA

- A. LTE is a common carrier as that term is defined in the Act. The Company will provide supported services in the State of Utah pursuant to 214(e)(1).
- B. LTE will offer all supported services enumerated under Section 254(c) using a combination of its own network facilities and the facilities of its underlying carrier Prepaid Wireless Group a facilities based T Mobile aggregator.
 Accordingly, the Company satisfies the requirements set forth in Section 214(e)(1)(A).
- C. The services that are supported by Federal Universal support mechanisms under Section 254(c) are:
 - a. Voice Grade Access to the Public Switched Telephone Network the ability to transmit and receive communications with a minimum bandwidth of 300 to 3,500 Hertz (47 C.F.R. 54.101(a)(1). LTE meets this requirement through its provision of voice communications services and interconnection to the public switched telephone network.
 - b. Local Usage a number of minutes of use provided free of charge (47
 C.F.R. 54.101(a)(2))).
 - c. Access to Emergency Services access to emergency services includes both access to 911 and E911 services to extent the local government has implemented such services (47 C.F.R. 54.101(a)(5)). LTE meets this requirement for access to E911 services through local public service answering points ("PSAPs").

- D. Upon certification as an ETC, LTE will participate in, and offer Lifeline services to qualifying low-income consumers and publicize the availability of the lifeline services in a manner reasonably designed to reach those likely to qualify for those services, as required by FCC Rules.
- E. LTE, will advertise the availability of the above-referenced services and the charges for those services in the Designated Service Area using media of general distribution as required by FCC Rules.

F. SATISFACTION OF APPLICABLE CONSUMER PROTECTION AND SERVICE QUALITY STANDARDS.

LTE will comply with all applicable state and federal consumer protection and service quality standards. If designated as an ETC, LTE will continue to provide services on a timely basis to requesting customers within the Designated Service Area.

G. LTE'S LIFELINE PLANS

Lifeline is a component of one of the four separate federal universal service fund mechanisms know as the "low-income support mechanism" and is defined in 47 C.F.R.54.401 as a "retail local service offering" available only to qualified low-income consumers for which qualifying low-income consumers pay reduced charges as a result of application of the Lifeline support amount" that includes the services or functionalities enumerated in 54.401(a)(1) through (a)(9), which the Company will use to "make available Lifeline services... to qualifying low-income consumers." LTE will offer a local usage plan comparable to

the one offered by the incumbent LEC in the service area for which it seeks designation. LTE will offer a local usage plan with unlimited calling within the customer's local calling area for a flat monthly fee with the same calling scope as the incumbent local exchange carrier. LTE will also offer customers an unlimited lifeline wireless plan with 5 GB of data for non-tribal customers and an unlimited minute lifeline wireless plan with 20 GB of data for customers that qualify for Enhanced Tribal Benefit free of charge. The Lifeline discount can be applied to any of LTE's generous local calling plans or home internet products. Eligibility will be checked using the National Lifeline Accountability Database ("NLAD").

CERTIFICATION FOR USE OF UNIVERSAL SERVICE FUNDS

LTE certifies that it will use the federal low-income universal support only for the provision, maintenance, and upgrading of facilities and services for which the support is intended in accordance with 47 U.S.C. 254(c).

IV. CONCLUSION

LTE requests designation as an ETC for the designated service area for the purpose of receiving federal low-income support and state low-income support.


