Application of LTE Wireless INC for Designation as an Eligible Telecommunications Carrier Pursuant to 47 U.S.C. § 214(e) DOCKET NO. 25-2658-01

NOTICE OF THIRD VIRTUAL SCHEDULING

On September 11, 2025, LTE Wireless INC ("Applicant") filed an application with the Public Service Commission (PSC) for designation as an Eligible

Telecommunications Carrier "throughout the non-rural areas of Utah for wireless services including tribal areas of the state for the purpose of receiving federal universal service support." ("Application")

By notice issued September 15, 2025, the PSC set a scheduling conference in this docket ("First Notice"). That notice advised that a scheduling conference would be held on September 22, 2025, at 1:00 p.m. ("First Scheduling Conference"), would be convened via Zoom, provided Zoom access credentials for participants, and provided alternative, non-Zoom, access information. The First Notice was sent to Applicant via U.S. Mail to the physical address listed in the Certificate of Service attached hereto, which is Applicant's only address of record with the PSC.

Legal counsel and representatives from the Division of Public Utilities (DPU) and the Office of Consumer Services (OCS) appeared at the First Scheduling Conference. Applicant did not appear at the First Scheduling Conference, so that

conference was adjourned without establishing a schedule for adjudication of this docket.

By notice issued September 23, 2025, the PSC set another scheduling conference in this docket ("Second Notice"). That notice advised that this scheduling conference was set for September 30, 2025, at 1:00 p.m. MDT ("Second Scheduling Conference"), would be convened via Zoom, provided Zoom access credentials for participants, and provided alternative, non-Zoom, access information. The Second Notice was provided to Applicant via U.S. Mail for the same reasons explained above relating to the First Notice. The Second Notice also specifically advised of the PSC's expectation that Applicant, through legal counsel or otherwise as provided in the Utah Administrative Code rules applicable in this docket, and all other parties, would appear at the Second Scheduling Conference and be prepared to discuss a schedule for adjudication of this docket.

Legal counsel and representatives from the DPU and OCS appeared at the Second Scheduling Conference. Applicant did not appear at the Second Scheduling Conference, so that conference was also adjourned without establishing a schedule for adjudication of this docket.

Applicant thus failed to appear at two separately scheduled and noticed scheduling conferences in this docket, and thus no scheduling order has been issued.

On October 17, 2025, the PSC received an email<sup>2</sup> sent by an unidentified person from Applicant stating, "I apologize for not being available for the previous conference and would like to reschedule so we can move this along as fast as possible." The email provides no explanation for Applicant missing two scheduled and noticed scheduling conferences and also inaccurately suggests Applicant missed only one previous conference. Applicant is advised that if it fails to attend this third scheduling conference, the Application will be dismissed, without prejudice, for Applicant's failure to participate in the docket.

Accordingly, by this third notice, the PSC advises that it will conduct a third virtual scheduling conference in this docket on **Friday**, **October 31**, **2025**, **at 1:00 p.m**. **MDT**. The conference will be held via Zoom at the following link: (https://utah-gov.zoom.us/j/6041317806?omn=89749027348). The PSC expects Applicant, through legal counsel or otherwise as provided in the Utah Administrative Code rules applicable in this docket, and all other parties, to appear and to be prepared to discuss a schedule for adjudication of this docket. The PSC further advises Applicant that it, or its legal counsel, should understand and follow the Utah Administrative
