ORDER GRANTING REQUEST TO
WITHDRAW APPLICATION

ISSUED: January 26, 2026

On September 11, 2025, LTE Wireless INC (“Applicant”) filed the above-captioned application (“Application”) with the Public Service Commission (PSC). As can be seen by the various docket entries, Applicant has had difficulties properly participating in this proceeding.

On January 7, 2026, Applicant filed a request to withdraw the Application. That request was substantively deficient, but those deficiencies were cured by Applicant's filing on January 9, 2026 (“Motion to Withdraw Application”).¹ Applicant represents that it “will file for designation [as an eligible telecommunications carrier] at a later time.”²

No party to this docket has objected or otherwise opposed the Motion to Withdraw Application.

Good cause appearing, the Motion to Withdraw Application is granted. However, because of Applicant's difficulties in this docket, if Applicant files another application with the PSC for designation as an eligible telecommunications carrier, Applicant is
