Attached for your notification are the following revisions to the Qwest Corporation d/b/a CenturyLink QC Exchange and Network Services Price List, submitted with a February 19, 2026 issue date and a March 1, 2026 effective date. Attachment A includes a list of pages.

Effective March 1, 2026, the monthly recurring charge (MRC) for most phone (voice) features, including but not limited to Caller ID, Call Waiting, and Call Forwarding, will increase by up to \$2.00 on or after March 1, 2026. In addition, the monthly recurring charge for Non-Listed and Non-Published Numbers will increase by up to \$5.00. Affected customers were notified not less than 30 days prior to the proposed effective date, and a copy of that notice is included with this filing. Some administrative text changes are included to update internal billing codes. In Section 105, Obsolete Exchange Services, *QWEST* (Business) Receptionist with *CALLER ID WITH PRIVACY*; Custom Calling (Business) Packages Call Waiting, Three-Way Calling and Call Forwarding – Variable, Three Way Calling; Call Waiting, Three-Way Calling, Speed Calling, 8 number capacity; Call Waiting, Three-Way Calling, Speed Calling, 30 number capacity; Call Waiting, Call Forwarding – Variable, Three-Way Calling, Speed Calling, 30 number capacity; Call Forwarding – Variable, Speed Calling, 8 number capacity; Call Forwarding – Variable, Three-Way Calling, Speed Calling, 30 number capacity; Three-Way Calling Speed Calling, 30 number capacity and Fax Package, each line arranged, are being deleted as there were no remaining customers subscribed to these grandfathered services.
