This filing revises the conditions under which the Company is obligated to distribute its directory information to the public without charge. Firstly, the language in the filing has been revised to make it clear that the decision on whether a directory is delivered, made available online or upon request, or not available at all, lies with the telephone directory publisher. This change is intended to ensure there is no ambiguity regarding the publisher's role in determining the availability of the directory. Additionally, we have added language to clarify that when the publisher decides to eliminate a particular directory, there will be no charge for any directory listing price plan. The only exception to this is for non-published services, as these listings are also restricted from Directory Assistance.

2.2 ESTABLISHING AND FURNISHING SERVICE (Cont'd)

2.2.7 ASSIGNING AND CHANGING OF TELEPHONE NUMBERS

1. The customer has no property right in the telephone number nor any right to continuance of service through any particular CO, and the Company may change the telephone number or CO designation of a customer whenever it considers it desirable in the conduct of its business.
2. In any case where existing service is continued for a new customer, the telephone number may be retained by the new subscriber only if the former customer consents and properly notifies the Company. Also, arrangements acceptable to the Company are made to pay all outstanding charges against the service.
3. The following nonrecurring charge applies to change a telephone number of a CO line or trunk at the customer's request. No charge applies to change the telephone number due to annoyance calls, or Company initiated number changes.
