Thank you for reviewing our notification. We just want to clarify Peerless Network, Inc. is the parent company of Peerless Network of Utah, LLC. The name change of Infobip Voice Inc. applies only to the parent entity (Peerless Network, Inc.) and should not affect Peerless Network of Utah, LLC.

The attached indicates "The new name will be Infobip Voice Inc., d/b/a Peerless Network of Utah, LLC," which is not correct. Infobip Voice, Inc. (formerly Peerless Network, Inc.) is the parent company of Peerless Network of Utah, LLC and is not doing business as Peerless Network of Utah, LLC. In other words, Infobip Voice Inc. is a separate entity from Peerless Network of Utah, LLC.

If we can clarify this in an amended notification, please let us know

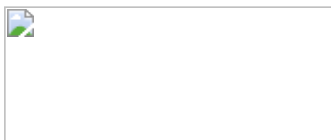
