- 1) To introduce the Advanced Option II for Small Business Savings Plans II and III under Option BB.

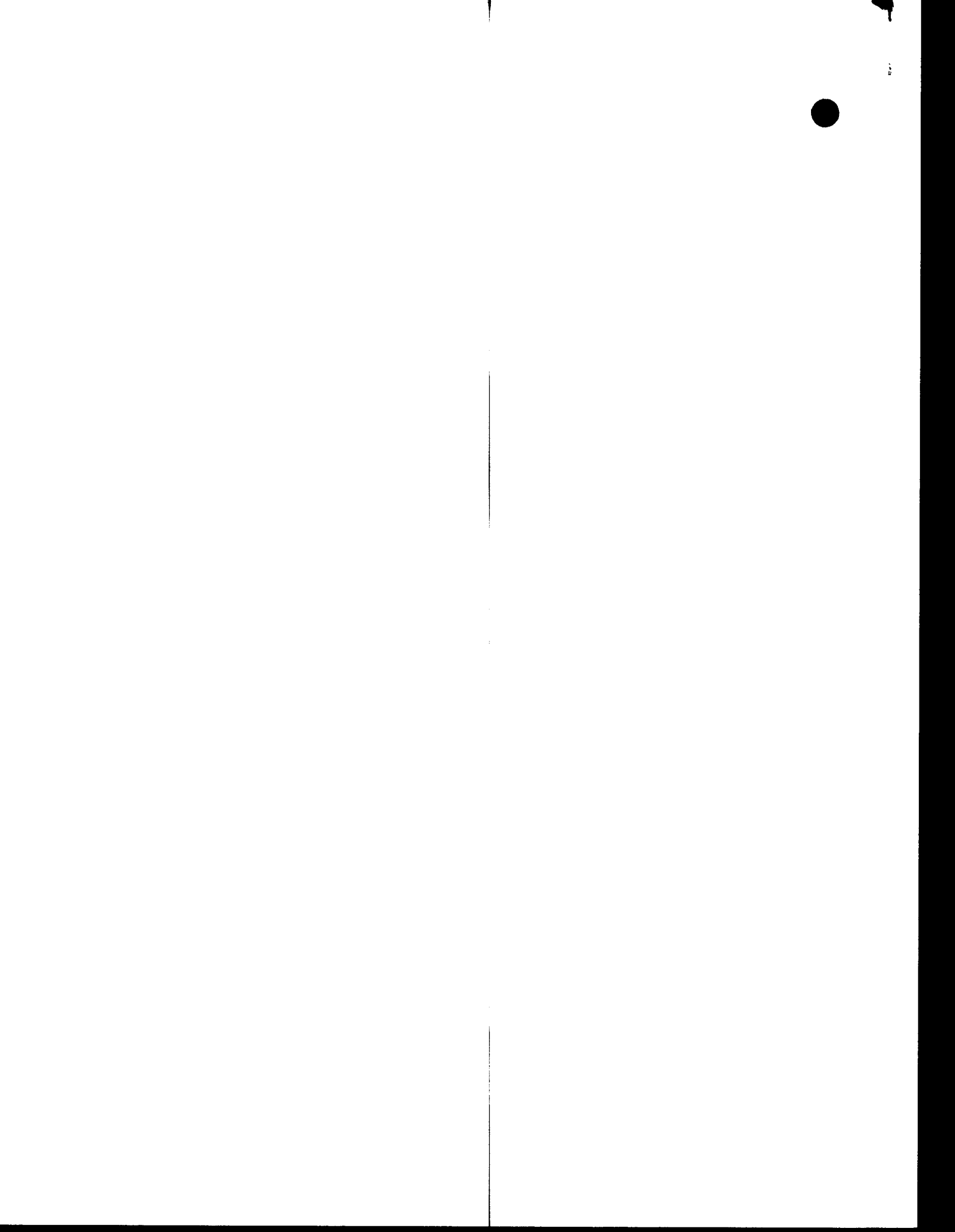
MCI respectfully requests that these revisions become effective on February 1, 1999.
