SYNOPSIS

The parties to the agreement, which is the subject of this proceeding, having submitted the same for Commission Approval; and the agreement appearing to conform to the requirements of § 252(e)(1) of the Federal Telecommunications Act of 1996 and applicable Federal Communications Commission regulations; and the agreement appearing to conform to applicable Utah law and Commission Regulations; and approval of the agreement appearing to be in the public interest, the Commission approved the agreement.

PROCEDURAL HISTORY

QWEST CORPORATION and ESSEX COMMUNICATIONS, INC., dba ELEC COMMUNICATIONS, entered into an interconnection and/or resale agreement (hereafter the Agreement) dated January 1, 2001. The parties filed the Agreement with the Commission on May 15, 2001, for review and approval in accordance with 47 U.S.C. 229 § 252(e)(1), a part of the Federal Telecommunications Act of 1996 (hereafter the Act).

The Administrative Law Judge, having reviewed said agreement and having been fully advised in the matter, now enters the following Report, containing proposed findings of fact, conclusions of law, and the Order based thereon.

FINDINGS OF FACT

1. We find the instant agreement does not discriminate against any telecommunication carrier not a party to it.
2. The Agreement comports with the Act's § 251, and with currently effective Federal Communications Commission (FCC) regulations.
3. The Agreement comports with applicable Utah law and this Commission's rules.
4. The United States Congress and the Utah Legislature having established the fostering of competition in the telecommunications industry as sound public policy, the Agreement is in the public interest, since it comports with such policy.
5. The Division of Public Utilities, Utah Department of Commerce, recommends approval of the agreement.

CONCLUSIONS OF LAW

The Agreement should be approved now as meeting the requirements of 47 U.S.C. § 252(e)(1).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that:

- The Resale/Interconnection agreement between QWEST CORPORATION and ESSEX COMMUNICATIONS, INC., dba ELEC COMMUNICATIONS, dated January 1, 2001, be and it hereby is, approved in conformance with 47 U.S.C. § 252(e)(1).
- Any person aggrieved by this Order may petition the Commission for review within 20 days of the date of this Order. Failure to do so will forfeit the right to appeal to the Utah Supreme Court.
