NOTICE OF INITIAL HEARING

By The Commission:

On September 30, 2002, Qwest Corporation ("Qwest") filed its Petition for Pricing Flexibility for Residential Services in this docket requesting that the Commission grant it pricing flexibility for specified residential services in the areas served by Qwest's Cottonwood, Draper, Holladay, Kearns, Magna, Midvale, Murray, Ogden Main, Ogden North, Ogden South, Orem, Park City, Provo, Salt Lake Main, Salt Lake South, Salt Lake West, and West Jordan Central Offices ("Petition"). According to the Revised Certificate of Service filed by Qwest, a Notice of Petition for Pricing Flexibility for Residential Services was served on competitive local exchange carriers on September 30 and October 1, 2002.

In accordance with Rule R746-351-4(C), the Commission hereby gives notice that it is not prepared at this time to grant or deny the Petition and that a hearing may be necessary to consider the Petition. The Commission further gives notice that an Initial Hearing shall be held on the Petition on Tuesday, October 15, 2002 at 9:00 a.m. in the Commission's main hearing room, Room 426 Heber M. Wells Office Building, 160 East 300 South, Salt Lake City, Utah. The purpose of the Initial Hearing is to identify issues to be resolved and to schedule further proceedings, if necessary. All persons should be aware that the Commission is required, pursuant to Utah Code Ann. § 54-8b-2.3(2)(b)(iv)(A), to enter its final order either granting or denying the petition within 90 days of the date the Petition was filed.
