It has come to the attention of the Commission that there is an error in the recent Report and Order Amending Certificate (“Order”) sent by the Commission on June 19, 2007. On page one of the Order, the second line down under SYNOPSIS it reads, “(the “Commission”) grants the request of Frontier Communications of America (“Application”)”. It should read, “(the “Commission”) grants the request of **Frontier Communications of America, Inc.** (“Applicant”)”. There is also an error on the first, second, and third line on the first page under PROCEDURAL HISTORY. It reads, “On May 14, 2007, Frontier Communications of America (“Applicant”) filed its Petition to Expand or Restate the Certificate of Public Convenience and Necessity of Frontier Communications of America to Include Facilities-Based Operations (“Application”) seeking”. It should read, “On May 14, 2007, **Frontier Communications of America, Inc.** (“Applicant”) filed its Petition to Expand or Restate the Certificate of Public Convenience and Necessity of **Frontier Communications of America, Inc.** to Include Facilities-Based Operations (“Application”) seeking”. There is an additional error on the second page of the Order, in the tenth line in the first paragraph under BACKGROUND AND DISCUSSION. It reads, “Not quite two years later, CLD acquired Applicant and changed its

name a second time, this time to Frontier Communications of America (“FCA”).” It should read “Not quite two years later, CLD acquired Applicant and changed its name a second time, this time to **Frontier Communications of America, Inc.** (“FCA”).” There is also an error on page five, in the second paragraph in the fourth line, under the ORDER. It reads, “said Certificate authorizes Frontier Communications of America to provide facilities-based public telecommunications services.” It should read, “said Certificate authorizes **Frontier Communications of America, Inc.** to provide facilities-based public telecommunications service.”
