2. All hearings set forth in the foregoing schedule shall be held in the Commission's main hearing room #426, fourth floor, Heber M. Wells Building, 160 East Third South, Salt Lake City, Utah unless otherwise noted. The hearings on September 15, 1999 will convene at 9:00 a.m. The schedule for a hearing on September 16, 1999, if necessary, will be as directed by the Commission.
3. Counsel for WWC Holdings Co., Inc. ("Voice Stream") is directed to prepare and circulate to all parties a form Confidentiality Agreement which will be used to cover all proprietary information requested and/or used in this matter.
4. At the hearings scheduled in this matter, all prefiled testimony will be received as exhibits, without being repeated verbally, but each witness will be given an opportunity prior to cross examination to make any necessary corrections and to give a summary of his or her testimony which shall also be prefiled in accordance with the Commission rules.
5. All discovery requests shall be in writing and shall be served upon legal counsel for the party from whom discovery is sought. Responses to discovery request shall be in writing and shall be served upon legal counsel for the party making the request.
6. Discovery responses shall be served as required by applicable Commission rules.
7. Voice Stream shall publish notice of the schedule, set forth in this Order, in two issues of at least two newspapers of general circulation in the State of Utah within one week of issuance of this Order.
