REVISED SCHEDULING ORDER

ISSUED: October 22, 1999

By The Commission:

On October 8, 1999, U.S. WEST Communications, Inc. ("US WEST"), filed a Motion To Dismiss Petition To Revise Resale Discount Rates ("US WEST's Motion").

US WEST's Motion was set for hearing on October 14, 1999. On October 13, 1999, Electric Lightwave, Inc. ("ELI"), filed a Motion for Extension of Time in Which To Respond to

US WEST's Motion To Dismiss Petition To Revise Resale Discount Rates and for Rescheduling of Hearing ("ELI's Motion"). ELI's Motion requested the Commission to reschedule the hearing on US WEST's Motion from October 14, 1999 to October 22, 1999 at 1:30 p.m. It also requested that the parties be given until October 19, 1999, to respond to US WEST's Motion. After receiving ELI's Motion, US WEST advised the Commission that it did not oppose the request to reschedule the hearing or to allow parties until October 19, 1999, to respond to its motion, but that its counsel was not available for a hearing on October 22, 1999, at 1:30 p.m., because of prior commitments. In light of this, US WEST asked if the Commission could convene a scheduling conference to deal with scheduling the hearing on its motion and testimony filing dates. The Commission requested that US WEST contact the other parties regarding the schedule and arrange a telephone scheduling conference if necessary. US WEST and the Division of Public Utilities ("Division") conferred regarding the schedule and the Division contacted all other parties regarding the proposed schedule. A proposed revised schedule was agreed upon and submitted to the Commission.

Based upon the foregoing and good cause appearing, the Commission establishes the following schedule for further proceedings in this docket.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

1. The following schedule shall apply in this docket in lieu of the procedure set forth in our Scheduling Order issued August 24, 1999:

October 19, 1999 Parties to respond to US WEST's Motion

October 26, 1999 Hearing on US WEST's Motion at 2:00 p.m.

October 29, 1999 Parties other than Division to file direct testimony

December 6, 1999 Rebuttal testimony to be filed

December 20, 1999 Surrebuttal testimony to be filed

January 6-7, 2000 Hearings at 9:00 a.m.

2. All of the foregoing hearings shall be held in the Commission's Hearing room, room 426, Heber M. Wells Office Building, Salt Lake City, Utah 84111.
