PROCEDURAL HISTORY

Pursuant to notice duly served, the above-captioned matter came on regularly for hearing the ninth day of June, 1999, before A. Robert Thurman, Administrative Law Judge, at the Commission offices, 160 E. 300 South, Salt Lake City, Utah. Complainants above-named appeared *in propria persona*. Evidence was offered and received, and the Administrative Law Judge, having been fully advised the in premises, now enters the following Report, containing proposed findings of fact, conclusions of law, and the Order based thereon.

FINDINGS OF FACT

1. Complainants are residential customer of Respondent, a telephone corporation certificated by this Commission.
2. Complainants allege they have been illegally denied access to 800 numbers while on toll restrict.
3. Respondent admits it has denied Complainants 800 access, but alleges that Complainants have used such access to evade the toll restriction.
4. Complainants failed to prove that Respondent has violated its tariff or any applicable law.

CONCLUSIONS OF LAW

The Commission has party and subject-matter jurisdiction. Sine Complainants have failed to prove facts which would entitle them to relief under Section 54-7-20, UCA 1953, as amended, the complaint must be dismissed.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

the complaint of ROGER B. and PATRICIA LIMB against SOUTH CENTRAL TELEPHONE ASSOC. be, and the same hereby is, dismissed.

If ROGER B. and PATRICIA LIMB wishes to proceed further, ROGER B. and PATRICIA LIMB may file a written petition for review within 20 days of the date of this Order. Failure so to do will forfeit the right to appeal to the Utah Supreme Court.
